

AITD FELLOW/ ASSOCIATE FELLOW APPLICATION FORM 2024

AITD's membership pathway aims to recognise the knowledge, skills, experience, and achievements of the training, learning and development and organisational development professions. Fellows and Associate Fellows are the highest tiers in the AITD membership pathway.

To apply for fellow or associate fellow membership, applicants must complete this form and submit it with payment to AITD. Once the application has been assessed, the applicant will be advised of the decision.

The Application Form comprises four (4) sections:

- 1. Criteria
- 2. Your personal details, Resume, and Qualifications
- 3. Your response to Criteria
- 4. Your Declaration

PART 1 | CRITERIA

A person may be appointed as a fellow/associate fellow provided all the following requirements are met:

ASSOCIATE FELLOW (AFAITD)

- Demonstration of significant contribution to the Learning and Development profession.
- At least five (5) years in Training, Learning and Development, or Organisational Development, and
- Recognised undergraduate qualifications in Learning and Development or a related discipline; the minimum requirement is a degree (AQF Level 7) or the equivalent professional experience.

FELLOW (FAITD)

- Demonstration of significant contribution to the Learning and Development profession,
- At least ten (10) years in Training, Learning and Development, or Organisational Development, and
- Recognised post-graduate qualifications in Learning and Development or a related discipline, the minimum requirement is either:
 - o a postgraduate qualification (AQF Level 9/10) in a related discipline or the equivalent professional experience; or
 - o an undergraduate degree (AQF Level 7) in a related discipline and a postgraduate qualification (AQF Level 8) in a related discipline or the equivalent professional experience.

Related disciplines are broad and may include vocational education and training, human resources, organisational development, talent development, eLearning, education, adult Education, and other emerging qualifications in related disciplines where a link to L&D is evident.
